# **Summary**

This is a draft amending plan under Part 2 of the *Kosciuszko Wild Horse Heritage Act 2018*. It details proposed amendments to the *Kosciuszko National Park Wild Horse Heritage Management Plan 2021* (the plan), which was prepared and adopted under the Kosciuszko Wild Horse Heritage Act.

Section 11 of the Kosciuszko Wild Horse Heritage Act provides that the Minister for Environment and Heritage may direct the Secretary of the Department of Planning and Environment (Secretary)<sup>i</sup>, to prepare a draft amending plan to make amendments to an adopted plan. Section 11 also provides for consultation requirements that apply to a draft amending plan, including public exhibition and providing a copy to the National Parks and Wildlife Advisory Council (Advisory Council) and the Heritage Council of NSW (Heritage Council).

The Minister must consider any representations made under Part 2 of the Kosciuszko Wild Horse Heritage Act by the Secretary, Advisory Council, Heritage Council and any other person (or, in the latter case, a summary of those representations) before adopting a draft amending plan. If the Minister adopts an amending plan (with or without alterations), the amended plan must be carried out and given effect to by the Secretary.

The proposed amendments to the Kosciuszko National Park Wild Horse Heritage Management Plan are to:

- identify that adjustments will be made to information about consultation to take account
  of the current amendment process (Executive Summary and section 2 of the
  Kosciuszko National Park Wild Horse Heritage Management Plan)
- update information on the size of the wild horse population, based on the most recent population survey (section 5 of the Kosciuszko National Park Wild Horse Heritage Management Plan)
- reference the national standard operating procedure for the aerial shooting of feral horses (section 6.1 of the Kosciuszko National Park Wild Horse Heritage Management Plan)
- include aerial shooting in the list of control methods available for use in controlling wild horses in the park (section 6.2 of the Kosciuszko National Park Wild Horse Heritage Management Plan)
- make minor amendments to align with the above.

## **Matters considered**

This draft amending plan:

- takes into account the object of the Kosciuszko Wild Horse Heritage Act, being to recognise the heritage value of sustainable wild horse populations within parts of Kosciuszko National Park and to protect that heritage
- considers the heritage value of sustainable wild horse populations within identified parts
  of the park, and how that heritage value will be protected while ensuring other
  environmental values of the park (including values identified in the plan of management
  for the park) are also maintained, as identified in the adopted Kosciuszko National Park
  Wild Horse Heritage Management Plan
- takes into account the objects of the National Parks and Wildlife Act 1974 and the
  matters that are required (by section 72AA of that Act) to be taken into consideration in
  the preparation of a plan of management, as addressed in Appendix A of the adopted
  Kosciuszko National Park Wild Horse Heritage Management Plan.

Consistent with the requirements of Part 5 of the *Environmental Planning and Assessment Act 1979* (EP&A Act), and section 6 of the adopted Kosciuszko National Park Wild Horse Heritage Management Plan, all matters affecting or likely to affect the environment by reason of undertaking activities associated with the Kosciuszko National Park Wild Horse Heritage Management Plan if it is amended as proposed, will be taken into account before implementation of the relevant wild horse control actions in the park or parts of the park.

As required by section 7 of the Kosciuszko Wild Horse Heritage Act, the Advisory Council and Heritage Council will be invited to make submissions on the draft amending plan.

The Kosciuszko Wild Horse Community Advisory Panel, constituted under the Kosciuszko Wild Horse Heritage Act, will also be invited to provide advice on the draft amending plan.

Development of the draft amending plan has been informed by a wide range of information, including scientific research, community views and commentary, population surveys, environmental research and monitoring, evaluations of the implementation of the adopted Kosciuszko National Park Wild Horse Heritage Management Plan, and review and assessment of wild horse management issues completed over time.



## What happens to your feedback?

- Step 1: At the close of the public exhibition period, all representations are considered and a summary representations report prepared.
- Step 2: The draft amending plan, any representations on the draft by the Secretary, public submissions and a summary of submissions, and any advice from the Advisory Council, Heritage Council and Kosciuszko Wild Horse Community Advisory Panel are provided to the Minister.
- Step 3: The Minister considers the draft amending plan and the information provided in Step 2 above, and decides whether to adopt the draft amending plan under the Kosciuszko Wild Horse Heritage Act.

## **Draft amendment**

This draft amending plan proposes to remove certain existing text in the Kosciuszko National Park Wild Horse Heritage Management Plan and replace with updated content, and add new content not currently in the Kosciuszko National Park Wild Horse Heritage Management Plan. The proposed changes should be read in conjunction with the adopted plan, which is available on the department's website.

Proposed amendments to the Kosciuszko National Park Wild Horse Heritage Management Plan are described below.

# Section 5 Protecting wild horse heritage values while maintaining other environmental values

As of November 2020, there were an estimated 14,380 wild horses in the park, with the 95% confidence interval for the estimate being 8798–22,555 wild horses (Cairns 2020).

### With:

As of November 2022, there were an estimated 18,814 wild horses in the park, with the 95% confidence interval for the estimate being 14,501–23,535 wild horses (Cairns 2022).

#### Reason

To update information about the wild horse population.

To clarify the example application for when ground shooting may be used.

#### Add:

#### Reason:

To include aerial shooting as one of the available control methods in the plan.

# Plan reference: pages 20-21, under and including the heading 'Aerial shooting' Delete:

### **Aerial shooting**

Animal welfare assessments advise that, if undertaken in accordance with best practice, aerial shooting can have the lowest negative animal welfare impacts of all lethal control methods (Kosciuszko Wild Horse Scientific Advisory Panel 2020; ITRG 2015).

However, there is a significant risk that the implementation of an aerial shooting program will result in a loss of the social licence to remove wild horses from the national park. In addition, government policy since 2000 has been not to undertake aerial shooting of horses in national parks. Taking these factors into account, this plan does not provide for aerial shooting.

#### Reason:
